You shall abide by the following conditions of probation:

1. You shall not violate any federal, state, county or municipal law or ordinance which is punishable by a fine and/or jail sentence
2. You shall report in writing to your assigned supervising agency (or the court if unsupervised) any arrest or violation of law.
3. You shall report in writing to your assigned supervising agency any change of address, telephone number or employment within 7 days from the date of such change.
4. You shall pay all fines and costs imposed on all cases of the amount \$ _____ by _____ (date).

An additional \$25.00 will be added to the court costs if you do not pay in full within 30 days of your guilty plea.

5. You shall submit to a breath or blood test upon the request of a law enforcement officer.
6. You shall not possess or use any controlled substance except as prescribed for you by a licensed medical practitioner.
7. You shall also abide by any of the following special conditions marked below:

- a. You shall complete _____ hours of community service within 90 days and provide written verification of completion from organization to your assigned supervising agency.
- b. You shall attend and complete the following program(s) at a center approved by the court within 90 days. Further, you shall pay all fees for said program.

c. You shall make VICTIM DAMAGE RESTITUTION in the sum \$ _____ payable to the Ste. Genevieve County Restitution Fund in monthly payments of \$ _____, beginning _____, 20____ and the same date of each month thereafter until paid in full.

- d. You shall not consume alcoholic beverages at any time during this probationary period.
- e. You shall not consume alcoholic beverages within 6 hours prior to or while operating a motor vehicle
- f. You shall not have any contact with any victim or witness on this case, or their families, nor shall you enter upon their residential or business premises, without the express consent of said victim, witness or business.
- g. You shall not associate with any person convicted of a misdemeanor felony.
- h. You shall not own, possess, purchase, receive, sell or transport any firearms, ammunition or explosive device or any dangerous weapon as defined by federal, state, or municipal laws or ordinances.
- i. You shall have an ignition interlock device installed on any vehicle you operate during the period of this order. Proof of installation must be provided to your assigned supervising agency the court (if unsupervised) by _____ (date). (See attached Order to Install Ignition Interlock Device.)
